2.	M.E. / M.Tech.	The candidate should have secured a minimum of 60% of marks in the aggregate of all subjects at B.E. / B.Tech. level or an equivalent examination from his / her home country / from India.
3.	B. Pharmacy	The candidate should have secured a minimum of 60% of marks / equivalent grade in the aggregate of Mathematics, Physics, Chemistry or Biology, Physics, Chemistry at 10+2 level (K12) or an equivalent examination.
4.	M.Pharmacy	The candidate should have secured a minimum of 60% of marks in the aggregate of all subjects at B.Pharmacy level or an equivalent examination from his / her home country / from India.

- vi. No Objection Certificate / Migration Certificate from the last studied Institute / University if pursued in India.
- NOTE: 1. The full name of the candidate is taken from the High School certificate /10+2 certificate. So, the candidate's name on the certificate should match with his/her name in the Passport. This office shall not accept any discrepancies in the name of the candidate.
  - 2. NRIs/ Children of the workers in Gulf Countries seeking admission into B.E. / B.Tech./ B.Pharmacy courses are required to submit the following certificates in addition to the above documents:
    - a. Bonafide/Certificates of study abroad.
    - b. NRI status certificates for the candidate and the parent(s).
    - c. Work permit of the parent(s) (Employment Certificate) working in the Gulf Countries.
    - d. Stamped pages of Passport of the parent(s) working in the Gulf Countries



#### OFFLINE ADMISSION PROCESS

The eligible foreign students seeking admission into <u>B.E./ B.TECH. / M.E./ M.TECH./ B.Pharmacy/ M.Pharmacy</u> programmes through offline mode can do so either by applying online and submitting physically if already in India or through an authorized person on his/her behalf (the authorization letter format can be downloaded from our website <u>www.oufro.ac.in</u>). However, they are required to follow the steps given below:

- Fill in the application online even if there is an authorized person to seek admission on your behalf and affix one passport size photo in the place provided. (Click on apply for online admissions on our website <a href="https://www.oufre.ac.in">https://www.oufre.ac.in</a>, and submit the print out)
- Fill all the details in the application form, take a print out of the filled-in application form.
- Submit the printout of the filled-in application form along with all the required documents.
- Pay the Registration-cum-Prospectus fee through a DEMAND DRAFT drawn in favour of "The Director, UFRO, OU" from any Nationalized Indian Bank, payable at Hyderabad or follow the online payment step mentioned in the online admission process.
- Submit the proof of the online/offline payment along with the filled-in application form which is mandatory for processing the offline applications. THIS REGISTRATION-CUM-PROCESSING FEE IS NON-REFUNDABLE.
